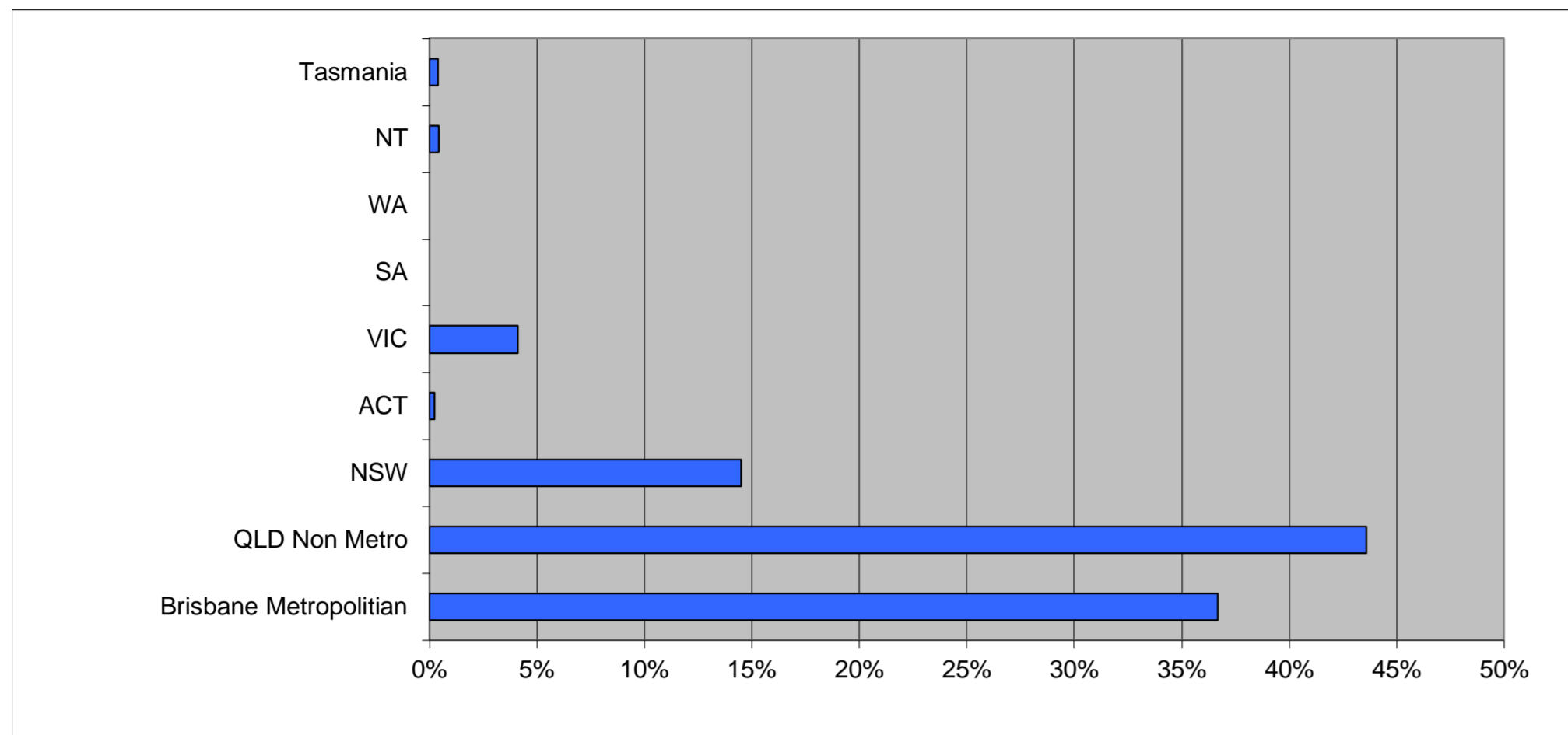

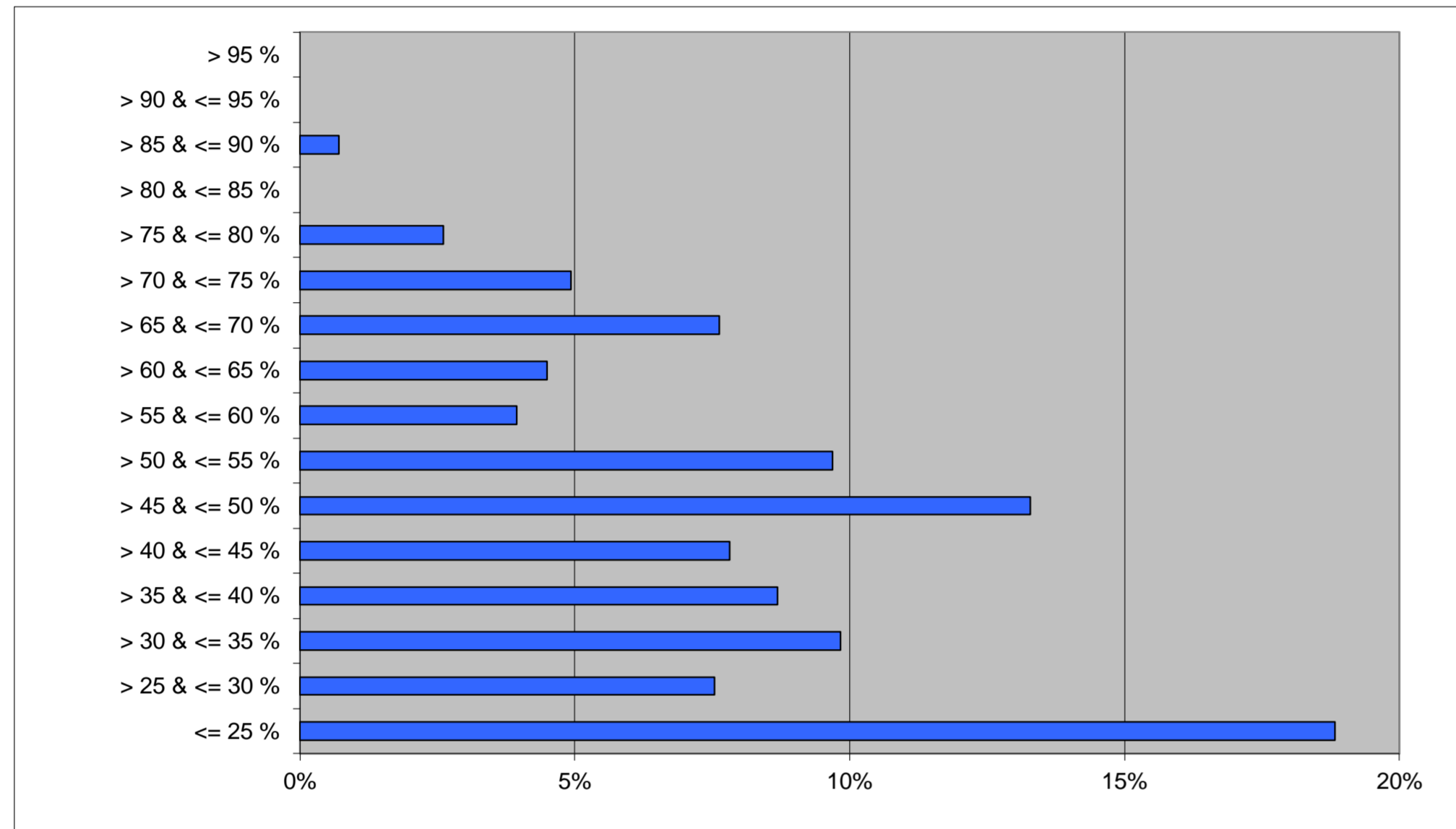

GEOGRAPHICAL DISTRIBUTION



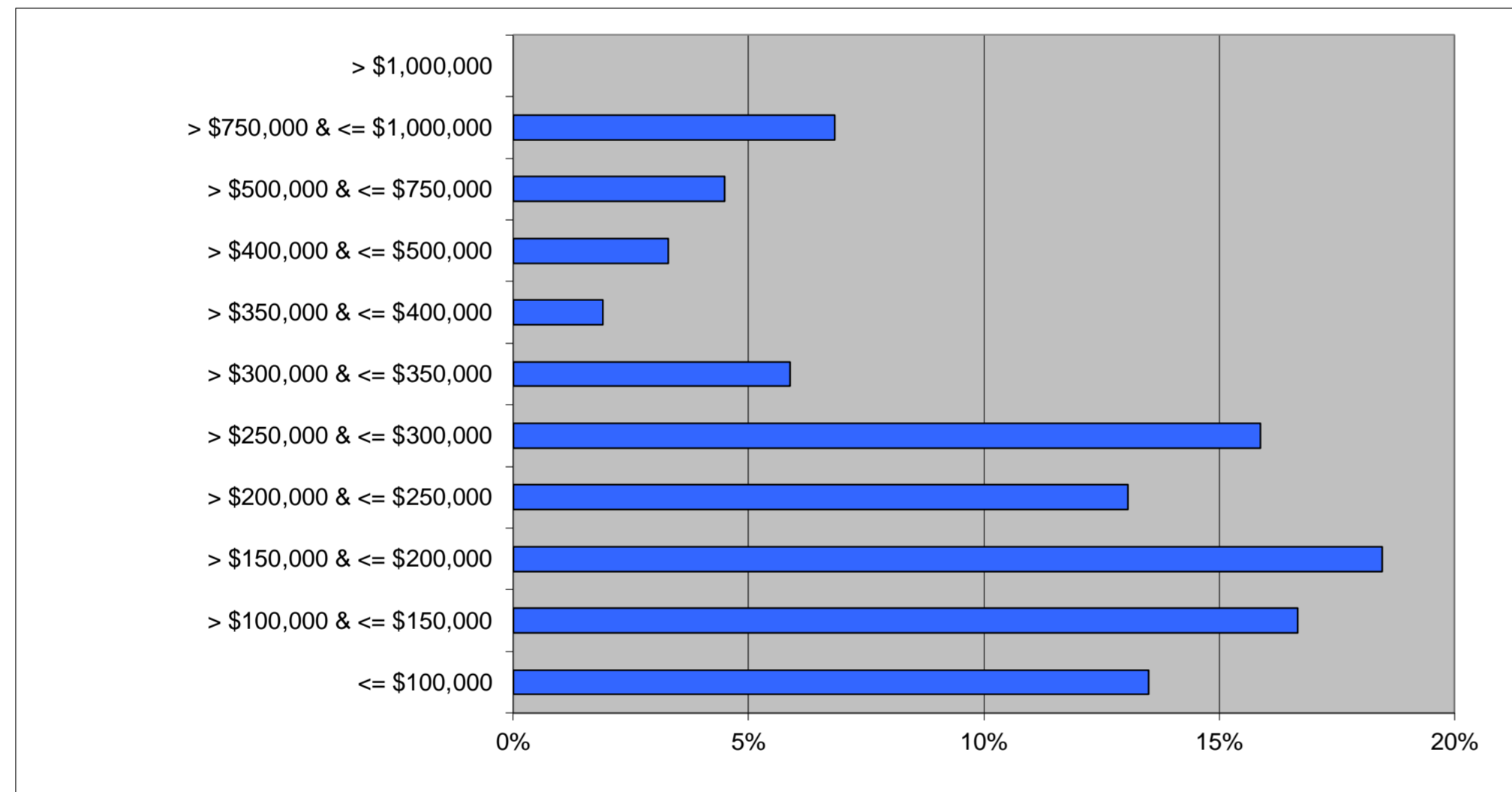

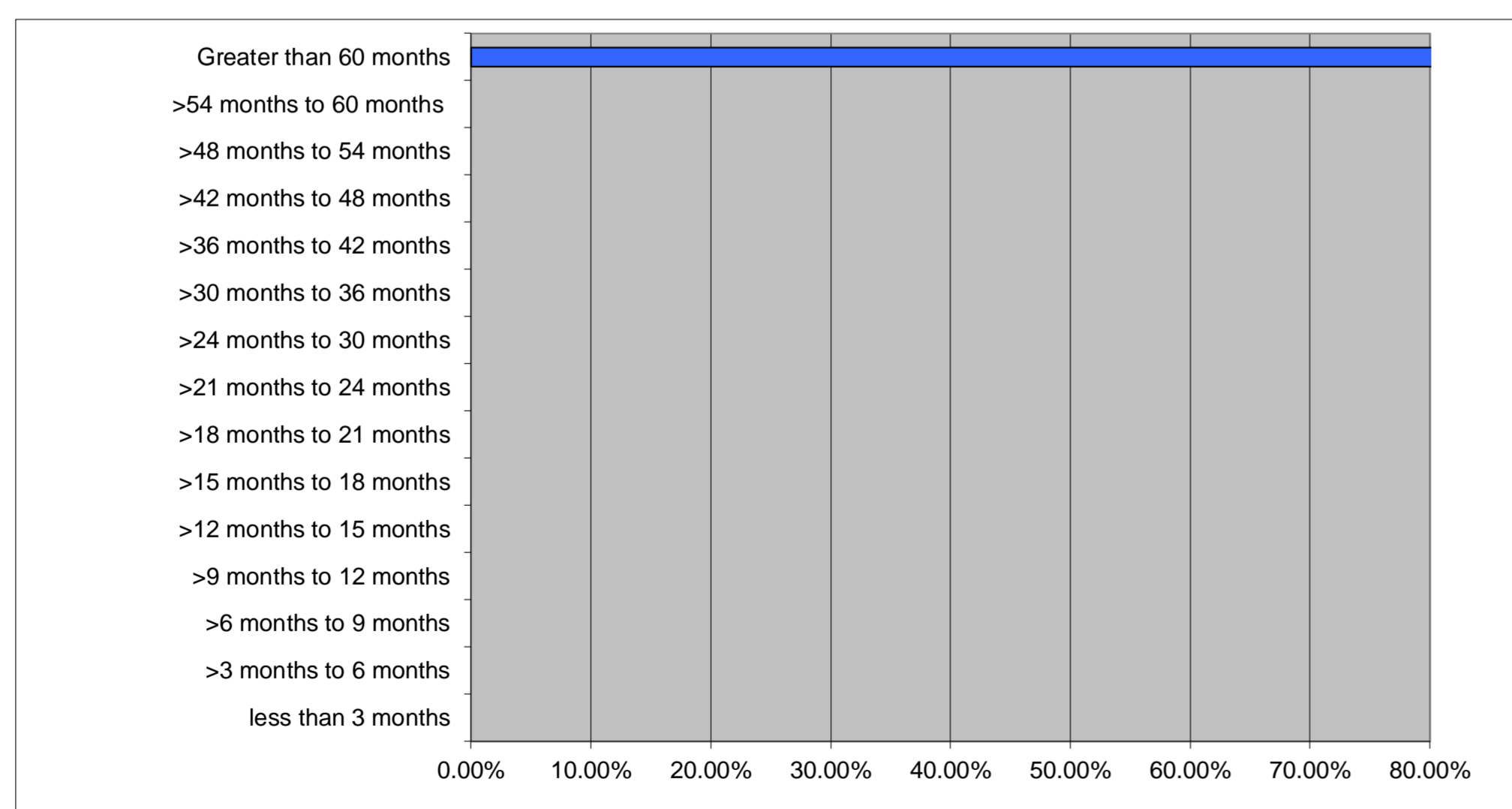

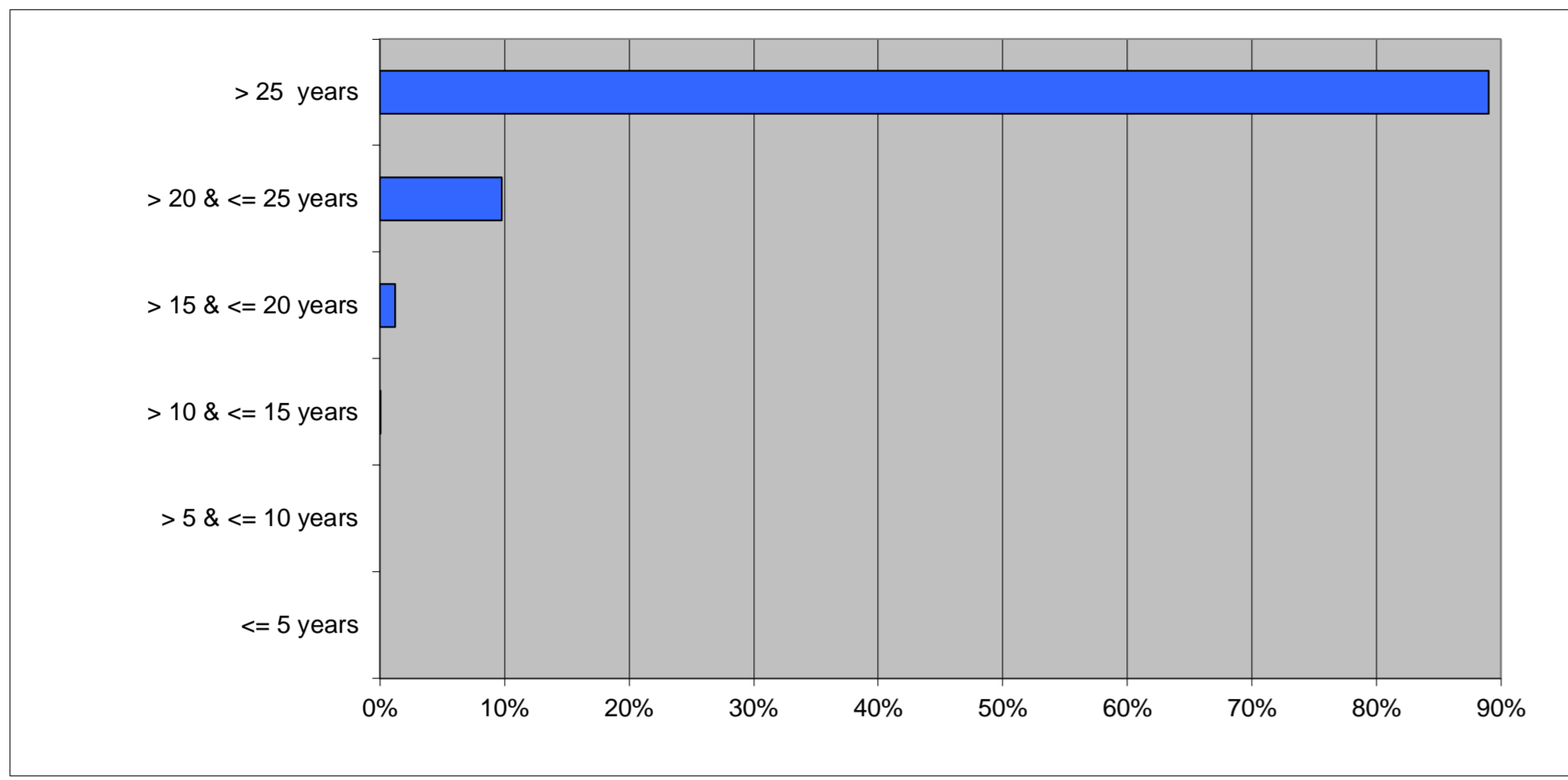

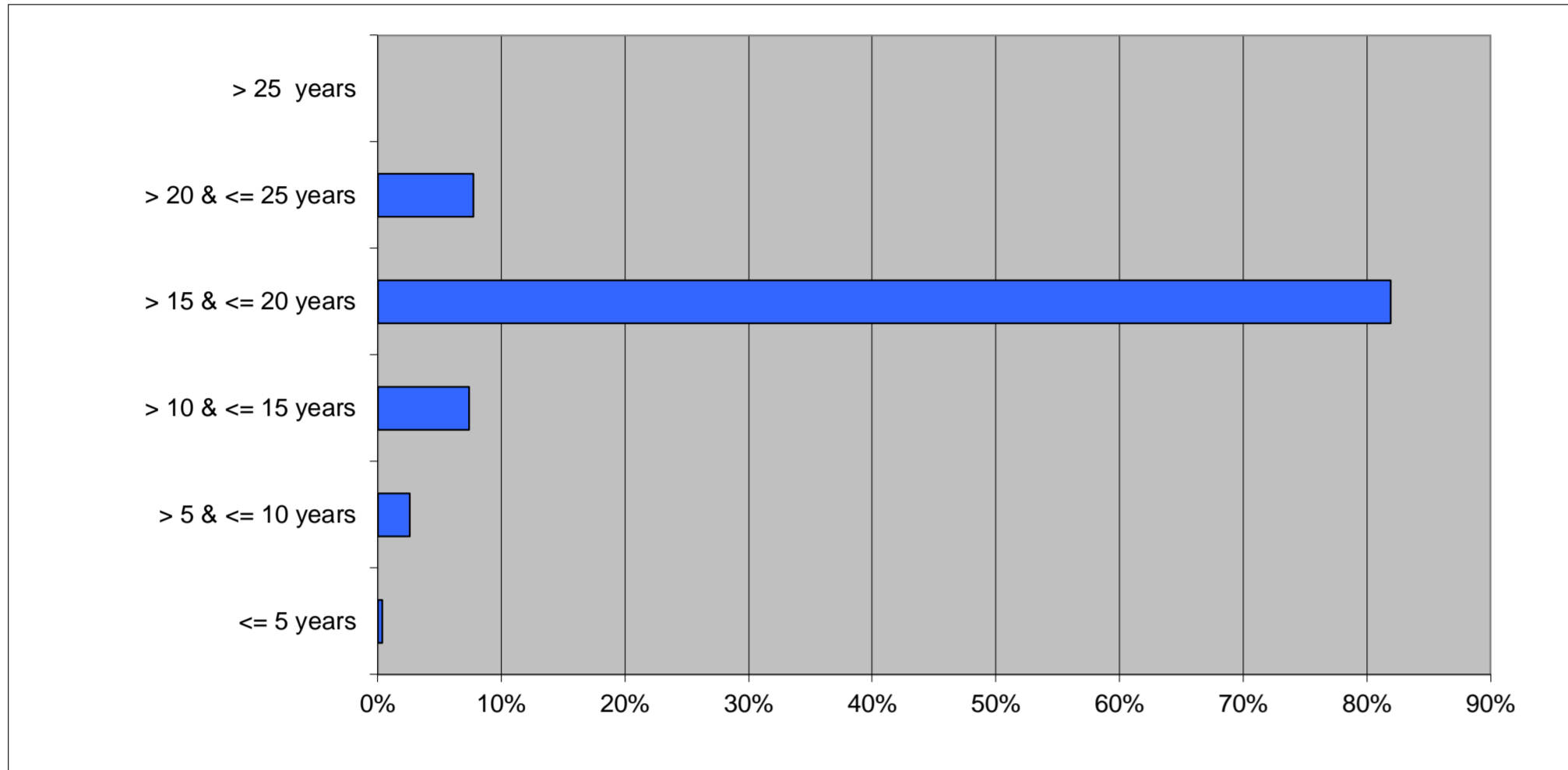

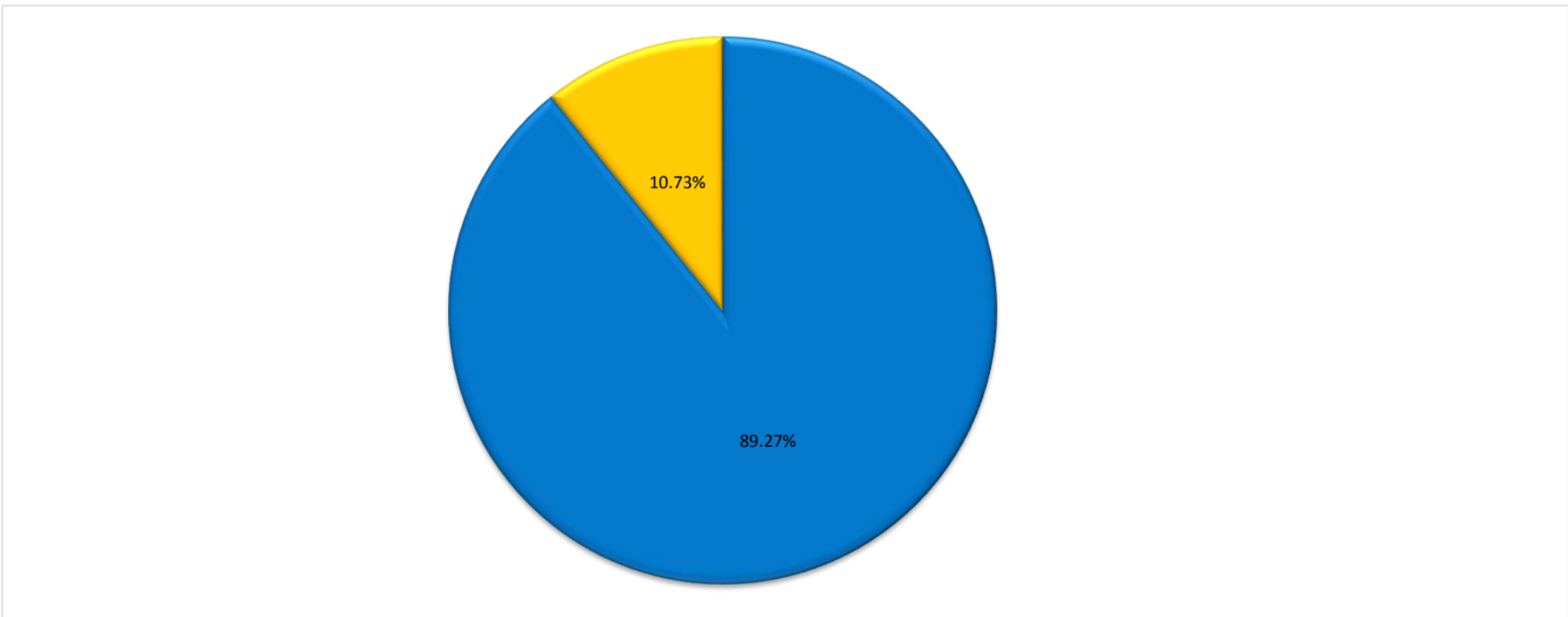

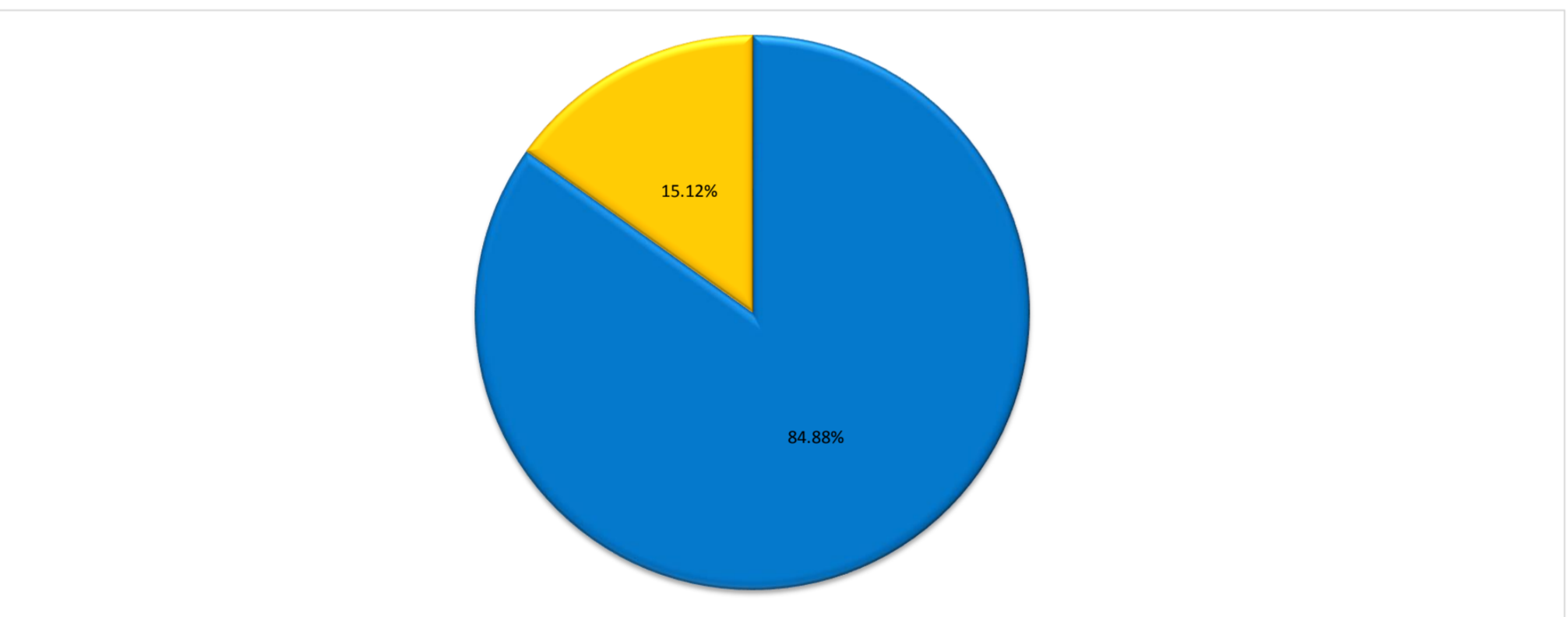
