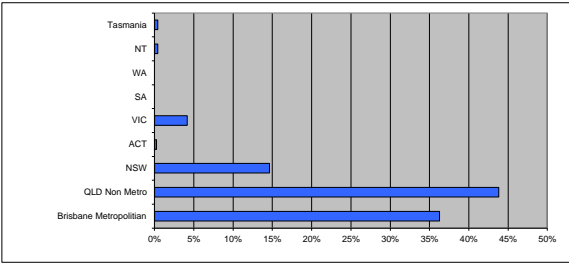

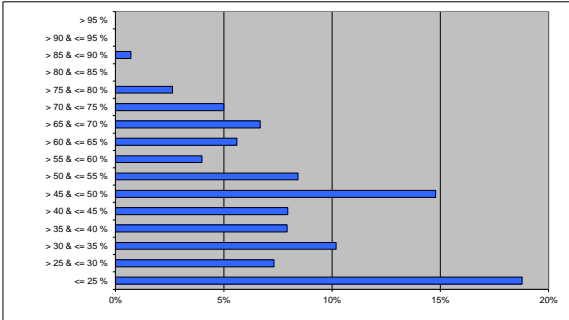

GEOGRAPHICAL DISTRIBUTION



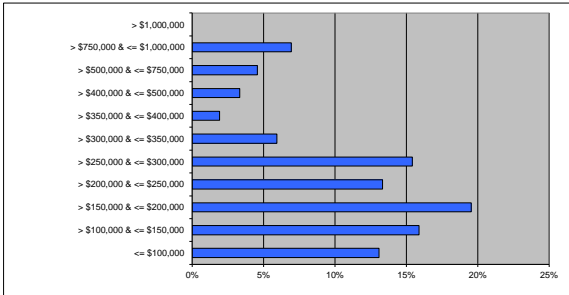

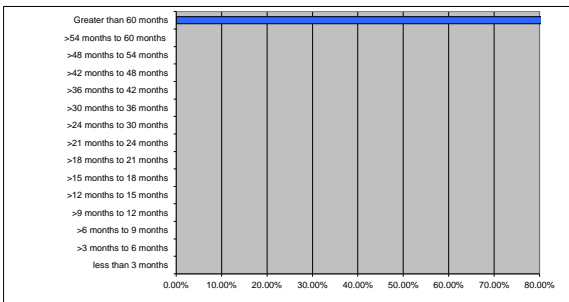

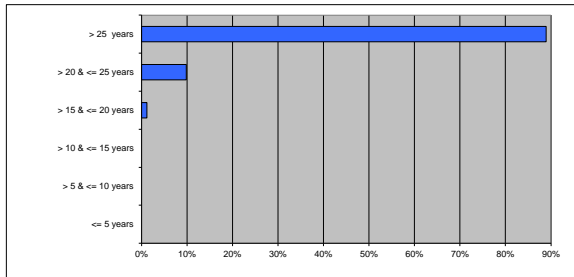

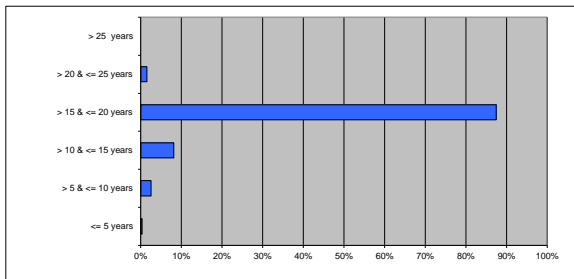

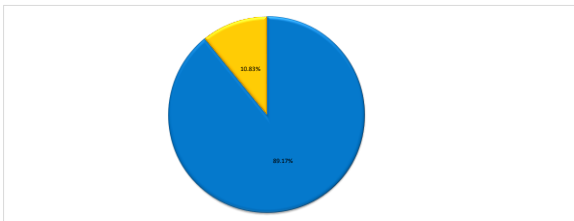

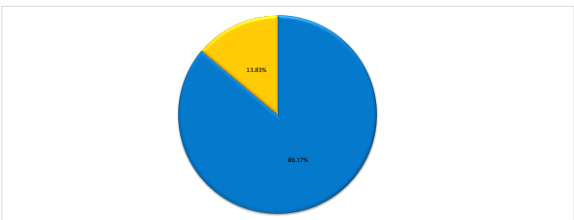
