

**Queensland Reds Home Game Double Pass 2026 Super Rugby Season
PROMOTION - TERMS AND CONDITIONS**

1. The Promoter of the Promotion is Bank of Queensland Limited ABN 32 009 656 740 of Level 6, 100 Skyring Terrace, Newstead, Brisbane QLD 4006 (**Promoter**) (BOQ). www.boq.com.au.
2. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions. If there is any conflict between these Terms and Conditions and any other published material, these Terms and Conditions will prevail.

PROMOTION PERIOD

3. The Promotion will be conducted across multiple periods (each, a **Promotional Period**). Each Promotional Period commences at 9:00AM AEST on the first date listed and closes at 11:59PM AEST on the final date listed for that period. Entries received by the Promoter after the Promotion Period are ineligible to participate in the corresponding prize draw.

The Promotional Periods are as follows:

- 9 March 2026 to 11 March 2026
- 30 March 2026 to 1 April 2026
- 6 April 2026 to 8 April 2026
- 27 April 2026 to 29 April 2026
- 4 May 2026 to 6 May 2026
- 25 May 2026 to 27 May 2026

ELIGIBILITY AND PARTICIPATION

4. Entry is only open to Australian Residents aged 18 years or over (**Eligible Entrant**).
5. Employees (and their immediate families) of the Promoter and agencies associated with this Promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.
6. During the Promotional Period, the Promoter will upload one promotional post to their Instagram (@bankofqueensland) account encouraging individuals to enter the promotion (**Promotional Post**).
7. To enter the Promotion, an Eligible Entrant must complete the following steps during the Promotional Period:
 - (a) Locate the Promotional Post on the Promoter's Instagram account;
 - (b) Post a direct comment to the Promotional Post commenting on the question Tell us in 25 words or less, to the question specified for that promotional period; and

- 6 April 2026 to 8 April 2026: Tell us in 25 words or less, your favourite Queensland Reds moment this season and why.
 - 27 April 2026 to 29 April 2026: Tell us in 25 words or less, your favourite Queensland Reds moment of all time.
 - 4 May 2026 to 6 May 2026: Tell us in 25 words or less, why being a Queensland Reds fan means more than just going to the games.
 - 25 May 2026 to 27 May 2026: Tell us in 25 words or less, your favourite Queensland Reds moment this season and why.
8. An Eligible Entrant will receive one (1) entry into the Promotion after they have completed all of the steps in the preceding clause (**Eligible Entry**). Only one (1) entry is permitted per Eligible Entrant. For clarity, if an Eligible Entrant posts more than one comment to the Promotional Post on the Promoter's Instagram account, the Eligible Entrant's first comment will be entered into the Promotion and all other comments will be disregarded. Entries are deemed to have been received at the time of receipt into the promotion database and not at the time of transmission by the Eligible Entrant.
 9. The Promoter reserves the right, at any time, to verify the validity of entries, entrants and winners (including identities, such as a driver's license or passport, age, email address and place of residence) and reserves the right, in its sole discretion, to disqualify any individual or group who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion.
 10. Incomplete or indecipherable entries will be deemed invalid.
 11. All Eligible Entrants who make a submission for the purpose of entering this Promotion agree that they are responsible for the information submitted in their entry and that the Promoter is not liable in any way for the contents of Eligible Entrant's entry. Eligible Entrants agree they will comply with the terms of use of Instagram (as applicable).
 12. Each Eligible Entrant warrants and agrees that:
 - (a) they will not submit any content that is unlawful or fraudulent, is in breach of any intellectual property, privacy, publicity or other rights, or is defamatory, obscene, derogatory, pornographic, sexually inappropriate, violent, abusive, harassing, threatening or objectionable with respect to race, religion, origin or gender;
 - (b) they will obtain prior consent from any person who is mentioned or pictured in their content or whose property is mentioned or pictured in their content; and
 - (c) they will not submit any content that contains viruses in any computer system.

PRIZE

13. There are two (2) prizes to be won during each Promotional Period, being two double-passes to the Queensland Reds home game taking place in the same week as the relevant Promotional Period at Suncorp Stadium, Milton QLD (**Prize**).
14. The total Prize pool value each Promotional Period is AU\$156.00.
15. The Promoter is not responsible or liable for any change in the value of the Prize between the date of the publication of these Terms and Conditions and the date the Prize is claimed.

16. The Prize, or any unused portion of the prize, is not transferable or exchangeable and cannot be taken as cash and is not redeemable for other benefits. The Competition is not available in conjunction with any other offer.
17. If the Prize (or part of any prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize (or that part of the prize) with a prize to the equal value and/or specification, subject to any written directions from a regulatory authority.

PRIZE WINNER

18. Judging to determine the winners of the Prize for each Promotional Period will take place at Level 6, 100 Skyring Terrace, Newstead, Brisbane QLD 4006 at 9:00AM AEST on the business day following the end of each relevant Promotional Period (**Judging Day**).
19. For each Promotional Period, two (2) prize winners who will be selected by a panel of three (3) judges employed and selected by the Promoter, in their sole and absolute discretion, from the cumulative pool of Eligible Entries received by the Promoter during that Promotion Period (**Prize Winner**).
20. This is a game of skill, and chance plays no part in selection of the Prize Winner.
21. The judges may select additional reserve entries which they determine to be the next best, and record them in order, in case of an invalid entry or ineligible entrant.
22. Each Eligible Entry received during the Promotion Period will be judged based on the extent to which the Eligible Entry best and most heartfully answers the question for the relevant Promotional Period. The two best Eligible Entries selected during the Promotion Period that is deemed by the judges at the judges' sole discretion to be the best and most heartfelt answer to this question will be the Prize Winners for that Promotional Period.
23. The judges will disregard any material which exceeds the 25 word limit.
24. Within one (1) business days from the Judging Day, the Prize Winners will be notified by message to their Instagram account and the Prize Winners' names will be published on the Promoter's Instagram. To accept the Prize, the Prize Winner must respond to the notification in the manner and within the timeframe set out in the notification provided by BOQ informing them of the fact they are a Prize Winner. Failure to respond as required, or at all, will result in the Prize Winner forfeiting the Prize.
25. If any Prize is unclaimed or forfeited, a Prize Winner is disqualified for any reason or a Prize Winner is unable to satisfy these Terms and Conditions, that Prize Winner will forfeit the Prize and the Prize shall be awarded to the next best Eligible Entry received during the Promotion Period (as determined by the judges in their sole and absolute discretion) in accordance with judging criteria outlined above. Any rejudged Prize winner will also be notified by message to their Instagram account and the Prize Winner's name will be published on the Promoter's Instagram. To accept the Prize, any rejudged Prize winner must respond to the notification in the manner and within the timeframe set out in the notification provided by BOQ informing them of the fact they are a rejudged Prize winner. Failure to respond as required, or at all, will result in the Prize winner forfeiting the Prize.
