TERMS AND CONDITIONS

- The Promoter of the promotion is Bank of Queensland Limited ABN 32 009 656 740 (BOQ) AFSL and Australian Credit Licence No 244616 of Level 3,100 Skyring Terrace, Newstead, Queensland 4006 (**Promoter**). The Promoter's website is www.boq.com.au.
- Information on how to enter and the prize(s) form part of these Terms and Conditions. If there is any conflict between these Terms and Conditions and any other published material, these Terms and Conditions will prevail.
- 3. By entering the promotion, participants are deemed to accept these Terms and Conditions.

The prize must be accepted as awarded and is subject to all of the applicable terms and conditions prescribed to such prize, including passing necessary sanctions screening. By accepting the prize the holder is deemed to have accepted all of the applicable terms and conditions prescribed to such prize, including any entry and COVID-19 requirements. Promotion Period

5. The promotion commences on 12am AEST on 5 May 2025 and closes at 11:59pm AEST on 31 July 2025 ("**Promotional Period**"). Entries received by the Promoter after the Promotional Period will be deemed invalid.

Eligibility and Participation

- 6. Entry is only open to Australian residents aged 18 years or over who (a) hold a BOQ Everyday Account with linked Visa Debit Card that has been activated (b) have not opted out of receiving marketing communications from the Promoter; and (c) can travel to the Singapore Race Weekend between 3 October 2025 6 October 2025 (Eligible Entrant).
- 7. Employees (and their immediate families) of the Promoter, and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
