BOQ "Taronga Zoo Wildlife Retreat" PROMOTION

TERMS AND CONDITIONS

- The Promoter of the promotion is Bank of Queensland Limited ABN 32 009 656 740 (BOQ) AFSL and Australian Credit Licence No 244616 of Level 3,100 Skyring Terrace, Newstead, Queensland 4006 (**Promoter**). The Promoter's website is www.boq.com.au.
- 2. Information on how to enter and the prize(s) form part of these Terms and Conditions. If there is any conflict between these Terms and Conditions and any other published material, these Terms and Conditions will prevail.
- 3. By entering the promotion, participants are deemed to accept these Terms and Conditions.

Promotion Period

4. The promotion commences on 1 August 2025 and closes at 11:59pm AEDT on 24 October 2025 ("**Promotional Period**"). Entries received by the Promoter after the Promotional Period will be deemed invalid.

Eligibility and Participation

- 5. Entry is only open to Australian residents aged 18 years or over who (a) hold a BOQ Everyday Account with a linked Visa Debit Card that has been activated; (b) have not opted out of receiving marketing communications from the Promoter; and (c) can travel to Sydney, NSW between 5/12/25 and 7/12/25 to attend the Taronga Zoo experience ("Eligible Entrant").
- 6. Employees (and their immediate families) of the Promoter, and agencies associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
- 7. An Eligible Entrant will receive one (1) automatic entry into the draw for each settled purchase transaction (not pending) of AUD\$60 or more made with their BOQ Everyday Account Visa Debit Card, during the Promotional Period (each a "Qualifying Transaction"). - 8. Incomplete transactions and transactions that are reversed or cancelled will be ineligible for entry. The following transactions will not be considered a Qualifying Transaction: BPAY and Pay Anyone transactions, Direct Debits, Cash outs from a merchant's point of sales terminal, Cash withdrawals from an ATM and purchases in the following Merchant Categories:

 - 4829 Money Transfers (including cryptocurrency);
 - 6051 Non-Financial Institutions (including cryptocurrency);
 - 5813 Drinking Establishments (Alcoholic Beverages); and
 - 5921 Package Stores Beer, Wine, and Liquor.

- Multiple entries are permitted, subject to the following: (a) only one (1) entry permitted per Qualifying Transaction (regardless of the amount spent in that transaction in excess of AUD\$60); and (b) each entry must be submitted separately and in accordance with entry requirements.
- 10. The Promoter reserves the right, at any time, to verify the validity of entries and entrants (including an entrant's identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.
- 11. If there is a dispute as to the identity of an Eligible Entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
- 12. In the event that the prize is won through an entry made using a joint BOQ Everyday Account, the Promoter may determine the identity of the entrant/winner associated with the joint BOQ Everyday Account at its discretion based on the details available. By participating in the promotion, all joint account holders acknowledge and agree to this stipulation and waive any claims or disputes regarding the allocation of the prize.

Prize

13. The first valid entry drawn will win a Taronga Zoo Experience Package for either two (2) adult guests **OR** two adult guests and one (1) child under the age of twelve (12), valued at up to AUD\$5,000 (depending on point of departure).

Package includes:

- Free Zoo access for the winner and their companion(s), including:

- 14. The total prize pool value is up to AUD\$5,000
- 15. For clarity, if the winner resides within 200km of Sydney, NSW, flights will **not** form part of their prize, and this element of the prize will be forfeited and will not be awarded as cash. The Taronga Zoo experience is subject to the event venue and ticket terms and conditions, including any applicable age restriction. The Promoter and event organisers hereby expressly reserve the right to eject the winner (and/or his/her companion(s)) for

- any inappropriate behaviour, including but not limited to intoxication, whilst participating in any element of the prize.
- 16. Itinerary to be determined by the Promoter in its absolute discretion. Frequent flyer points will not form part of the prize. Prize is subject to the standard terms and conditions of individual prize and service providers.

- 20. All travel is always subject to availability and may be dependent on select seat class with airlines or specific room category availability with an accommodation partner. The winner is responsible for any amendment fees issued by airlines or suppliers once booking is confirmed and ticketed. It is the responsibility of the winner and their guest(s) to hold valid travel insurance for their period of travel.
- 21. The winner of the prize and their nominated guest(s) are responsible for all other costs or expenses relating to the prize and its acceptance and redemption not otherwise specified in these terms and conditions, including, but not limited to additional spending money, meals (other than those included), taxes (excluding airline and airport taxes), insurance, transport to and from departure point, additional transfers, items of a personal nature, inroom charges, mobile data and all other ancillary costs incurred by the winner of the prize and their nominated guest(s). In the event of cancellation or change of date of the Taronga Zoo experience for any reason, the tickets will not be rescheduled, nor will any other prize be offered in its place.
- 25. The Promoter is not responsible or liable for any change in the value of the prize between the date of the publication of these Terms and Conditions and the date the prize is claimed.

Prize Draw

The winner will be notified by telephone and email within two (2) business days of the draw, and their details (first initial, surname and postcode) will be published online at https://www.boq.com.au/personal/banking/everyday-transaction-account from 7 November 2025.
- 28. If for any reason the prize remains unclaimed by 9:29am AEDT on 26 November 2025, a re-draw will take place at 9:30am AEDT on 26 November 2025 at the same place as the original draw, subject to any directions from a regulatory authority. The winner (if any) will be notified by telephone and email within two (2) business days of the re-draw, and their details (first initial, surname and postcode) will be published online at https://www.boq.com.au/personal/banking/everyday-transaction-account on 28 November 2025.
- 29. The Promoter's decision is final and no correspondence will be entered into.
- 30. Subject to the unclaimed prize draw clause, if for any reason the winner does not take the prize (or an element of the prize) by the time stipulated by the Promoter, then the prize (or that element of the prize) will be forfeited.
- 31. Liability

- 33. If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law:

 (a) to disqualify any entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the promotion, as appropriate.
- 34. Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal

- injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.
- 35. Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) if the Taronga Zoo experience is delayed, postponed or cancelled for any reason beyond the reasonable control of the Promoter; (f) any tax liability incurred by a winner or entrant; or (g) use of the prize / taking of the prize / participation in the prize. These Terms and Conditions (and any non-contractual disputes/claims which arise out of or in connection with them) will be governed by the relevant local courts who shall have exclusive jurisdiction over any and all disputes arising out of, relating to or concerning these Terms and Conditions.
