Terms and Conditions: BOQ's First Home Buyers Competition

- The Promoter of the BOQ's First Home Buyers Competition (Promotion) is Bank of Queensland Limited ABN 32 009 656 740 of Level 6, 100 Skyring Terrace, Newstead, Brisbane QLD 4006 (Promoter) (BOQ). Telephone: 1300 55 72 72 www.boq.com.au.
- 2. The Promotion commences on 5th February 2018, at 9:00am AEST and closes on 31st March 2018 at 5:00pm AEST (**Promotion Period**). Entries received by the Promoter after the Promotion Period are ineligible to participate in the Promotion.
- 3. By entering the Promotion, participants are deemed to accept these terms and conditions (**Terms** and **Conditions**).
- 4. Information on how to enter and prize details form part of these Terms and Conditions. If there is any conflict between these Terms and Conditions and any other published material, these Terms and Conditions prevail to the extent of any inconsistency.

Eligibility and Participation

- 5. The Promotion is open to Australian residents who:
 - 5.1 are aged 18 years and over;
 - 5.2 are personal customers; and
 - 5.3 are a first home buyer* who must not have previously owned a residential or investment property in Australia. For joint home loan applicants, neither applicant can have previously owned a residential or investment property in Australia.

(Eligible Person)

*In order to be eligible to claim the Prize, the winner will be asked to provide and must provide to the Promoter within the timeframe provided, evidence to the Promoter's satisfaction, and as relative to the applicable State/Territory, to support the fact that they are a first home buyer (eg. stamped transfer form or settlement statement from the applicant's solicitor/conveyancer evidencing first home buyer's stamp duty exemption).

- 6. The Promoter reserves the right at its discretion to determine the identity of the Eligible Person if there is a dispute as to the identity of the Eligible Person.
- 7. Directors and employees (and their immediate families) of the Promoter and its agents are ineligible to enter.
- 8. To enter the Promotion, an Eligible Person must, during the Promotion Period:
 - 8.1 Submit a new home loan application for a BOQ home loan (Economy, Clear Path, Standard Variable, Home Loan Privileges Package, Fixed Rate Home Loans, Line of Credit, First Start Home Loan) to the value of \$150,000 or over between 5th February 2018 and 31st March 2018 and which, upon obtaining unconditional approval, settles (ie. is funded) on or before 3rd June 2018; and
 - 8.2 Advise BOQ at time of loan application that you are a first home buyer.

(Eligible Entry)

- 9. An Eligible Person who submits an entry during the Promotion Period in accordance with these Terms and Conditions will receive one (1) entry in the Promotion (Eligible Entry). Only one (1) Eligible Entry is permitted per Eligible Person. In the case of joint or multiple borrowers, only one (1) Eligible Entry is permitted per loan application, which entry will be in the name of the main applicant.
- 10. Each participant who submits an entry (whether or not an Eligible Entry) to the Promotion warrants and agrees that they are fully responsible for entering the Promotion and that the Promoter is not liable in any way in this regard.

11. The Promoter reserves the right, at any time, in its sole and absolute discretion to verify the validity of entries and Eligible Persons (including their identity, age and place of residence) and reserves the right, in its sole discretion to disqualify any Eligible Person who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process, or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the Promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

Prizes

- 12. There is a total of one (1) prize to be given away being one (1) x \$25,000 cash payment deposited into a BOQ transaction account ("Prize").
- 13. Subject to clause 5, the Prize will be deposited into the winner's nominated BOQ transaction account (if not already opened, a BOQ transaction account must be opened in order to claim the Prize) within seven (7) days of the Prize winner, responding in the manner and within the timeframe set out in the notification letter, provided by BOQ informing them of the fact they are a Prize winner. Failure to respond as required, or at all, will result in the Prize winner forfeiting the Prize.
- 14. Where the Prize winner is one of joint or multiple applicants/borrowers in the loan application:
 - the Promoter will deposit the Prize into the BOQ transaction account of the winner in the first instance or any of the joint applicants/ borrowers;

Prize Draw

- 20. Subject to clause 24, if for any reason the Prize winner does not take / redeem the Prize by the time stipulated by the Promoter, then the Prize will be forfeited.
- 21. If any Prize is unavailable, the Promoter, in its discretion, reserves the right to substitute the prize (or that part of the prize) with a prize to the equal value and/or specification, subject to any written directions from a regulatory authority.

- 27. The Promoter is not responsible for any ancillary costs incurred by accepting the Prize, entering the Promotion or redemption of the Prize.
- 28. Any and all decisions of the Promoter in relation to any aspects of the Promotion are final and binding on every Eligible Person and no correspondence will be entered into by the Promoter.

Taxation

The Promoter liability

- 30. The Promoter and its agents will not be liable for any losses or damages whatsoever (including but not limited to direct or consequential loss) or personal injury suffered or sustained, in connection with the Promotion, the receipt, acceptance or use of the Prize or any act or omission (whether negligent or not) of the Promoter or its agents, employees and contractors, except for any liability that cannot be excluded by law.
- 31. The Promoter is not responsible for any failure of equipment or programming associated with or utilised in the Promotion, or for any technical error, or any combination thereof that may occur in the course of the administration of the Promotion including any omission, interruption, deletion, defect, delay in operation or transmission, communications line or telephone, mobile or satellite network failure, theft or destruction or unauthorised access to or alteration of applications or entries.
- 32. The Promoter and its agencies do not accept liability for any error or omission that may result in an Eligible Entry not participating in the prize draw.
- 33. If for any reason the Promotion is not capable of running as planned due to infection of data by computer viruses, bugs, tampering, unauthorised intervention, fraud, technical failures or any other causes beyond the control of the Promoter, which corrupt or affect the administration, security, fairness or integrity or proper conduct of the Promotion, the Promoter reserves the right in its sole discretion to disqualify any individual from participating in this Promotion, and subject to any written directions from a regulatory authority, cancel, withdraw, terminate, modify or suspend the Promotion.

Entrants consent to the Promoter using their name, likeness, image and/or voice in the event they are a winner (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose of promoting this Promotion (including any outcome), and promoting any products or services, distributed and/or supplied by the Promoter.

- 35. The Promoter collects personal information ("PI") in order to conduct the Promotion and may, for this purpose, disclose such PI to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities.
