TERMS AND CONDITIONS

- Information on how to enter and the prize(s) form part of these Terms and Conditions.

 If there is any conflict between these Terms and Conditions and any other published material, these Terms and Conditions will prevail.
- 3. By entering the Promotion, participants are deemed to accept these Terms and Conditions.

PROMOTION PERIOD

4. The Promotion commences at 10:00AM AEDT on 13 January, 2025 and closes at 5:00PM AEDT on 10 February, 2025 (**Promotional Period**). Entries received by the Promoter after the Promotional Period are ineligible to participate in the prize draw.

ELIGIBILITY AND PARTICIPATION

- 5. Entry is only open to Australian residents aged 18 years or over (**Eligible Entrant**).

PRIZE DRAW
